V. Gather Input for Collaboration Needs Survey-Martha Kauffman

NPCN recently received a sub grant from the Margaret A Cargill Foundation through WWF to develop and distribute a survey in collaboration with the National Fish and Wildlife Foundation. VI. Presentation: Building Drought Resilience in Montana-Ann Schwend, Montana Department of Natural Resources and Conservation

Montana and the National Drought Resilience Partnership (NDRP) are channeling federal and state resources to build local capacity and empower communities to develop locally-adapted

drought management plans in the Missouri Headwaters Basin. These community-led drought plans will provide the basis for a Basin plan to connect mitigation strategies across the broader landscape. This pilot project will develop a model for replication in the region.

VII. Presentation: Pallid Sturgeon and Threat from Dam Construction on Yellowstone River-Steve Forrest Defenders of Wildlife

Pallid sturgeon have been prevented from accessing spawning grounds due to dam development in the upper Missouri River Basin. Defenders of Wildlife and the Natural Resources Defense Council, with the support of a number of other Montana conservation organizations and the Montana fish science community, have challenged a proposal to build a new dam on the Yellowstone River. Steve Forrest will give an update on the growing collaborative effort to engage this issue, outreach to delegations, growing input from scientists and uncertainty, and next steps.

Field Trip October 6th

8:30-4:30

The group will travel North of Billings about an hour and a half to tour two sites on the Musselshell River. We'll be joined by Leon Hammond, Deadmans Basin project manager, Laura Nowlin, coordinator for the Musselshell Watershed Coalition and Mike Ruggles fisheries biologist with Montana Fish, Wildlife and Parks (FWP).

The group will first tour of the recently completed Deadmans Basin Dam Rehabilitation Project with fish passage. We'll also hear about the positive impact cooperation and collaboration of various user groups for the Musselshell, have had on this nearly 200 mile river between Shawmut and Mosby Montana.

The group will stop for lunch at Deadmans Reservoir Fishing Access Site before heading to our second tour site. Downstream from the Deadmans Diversion, the group will visit a dam removal project by FWP and a local landowner. Removal of the Egge Diversion Dam will restore natural flow patterns and bank lines of the Musselshell River while maintaining fish passage.

Transportation will be provided. There will be an opportunity to purchase lunch on our way out of Billings.
